

**VALVOLINE AT ADVANCE AUTO PARTS ULTIMATE MOTORSPORTS SUMMER SWEEPSTAKES
OFFICIAL RULES
SWEEPSTAKES VOID WHERE PROHIBITED**

1. PARTICIPATION CONSTITUTES ACCEPTANCE OF RULES. Sweepstakes is sponsored by Valvoline, LLC, Lexington, KY 40509 (“Sponsor”). Sponsor is not responsible for printing errors in these Official Rules. Void where prohibited, taxed or otherwise restricted by law. The Sweepstakes is subject to all federal, state and local laws.

2. Eligibility: This Sweepstakes is open to all legal United States residents residing in the fifty (50) United States, the District of Columbia and Puerto Rico who are 18 years of age or older. Any person who attempts to enter with multiple identities or uses any device or artifice to enter multiple times in the same day will be disqualified and forfeits any and all prizes won, in Sponsor's discretion. All requested information on the entry form at the Website must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. The use of any device to automate the entry process is prohibited.

Sponsor will attempt to notify potential prize winner by phone or email address or other delivery method as determined at the sole discretion of Sponsor.
